Minutes

of the Council Meeting held

Tuesday 9th July 2024 in the Gawsworth Village Hall

24/037 PRESENT

Cllrs Shepherd (*presiding*), Hardy, Clarke, Dempsey, Mitchell and Woods

24/038 APOLOGIES FOR ABSENCE

Apologies were received from Cllrs Kinsey, Richards and Wright.

24/039 DECLARATIONS OF INTEREST

No member declared an interest in any item.

24/040 PUBLIC PARTICIPATION

A representative of Gawsworth Scouts enquired about the scouts supporting an activity in the park.

Cllr Clarke joined the meeting.

24/041 APPROVAL OF PREVIOUS MINUTES

It was **RESOLVED** to approve the minutes of the meeting held 11th June subject to a typographical correction to 24/033.

24/042 CHESHIRE EAST COUNCILLORS REPORT

Cllr Puddicombe reported that the members of the council's Economy and Growth committee had walked the Danes Moss SSSI site and that the application for the SMDA was now solely in the name of Barratt Homes and not Engine of the North. Cllr Puddicombe

further highlighted impending changes to household waste recycling centres, noting the council's concern but stating he had not observed any queuing at the Macclesfield site to date and invited feedback from residents of Gawsworth Moss in relation to the change of polling station.

Cllr Wilson noted the reduction of polling stations stating these are under continual review, highlighted the recent election of Tim Rocca as the new Member of Parliament for Macclesfield and noted the continued financial challenges for the council.

24/043 CHRISTMAS LIGHT SWITCH ON ARRANGEMENTS

It was noted that a quote was awaited for the installation of an electricity supply at Penningtons Lane but that a site meeting with Cheshire East Highways had been held.

It was agreed to provisionally set a date of 30th November for the switch on event in the village, to follow the Scouts event for which details were shortly to be confirmed. It was agreed to approach the churches to support the event with carols and the Hub for mince pies and mulled wine and that a brass band be booked.

24/044 PLANNING MATTERS

24/1848M – 20 Harrington Drive

It was **RESOLVED** to raise no objections.

24/045 STREETNAME PLATE REPLACEMENTS

It was **RESOLVED** to approve the purchase of replacement signs for Surrey Road, Woodhouse Lane and Rising Sun Road.

24/046 PLAY AREA IMPROVEMENT PROJECT

It was reported that the deadline for tenders was the forthcoming Friday and that the working group would be meeting the following week to review them ahead of consultation activity in late August.

It was noted that two joints need repairing on the climbing net.

24/047 PARISH MATTERS

Cllr Mitchell reported that potholes on Dark Lane had been filled, drains remained uncleared, that there was overgrowth between Nancy's Wood and the Hall narrowing the pavement and that a strong scent emanated from fields past the Harrington Arms, querying what was being used that was so pungent.

Cllr Woods highlighted the extent of overgrowth along the A536 obstructing the pavements.

Cllr Dempsey reported that the gate at the car park requires replacement and that works in the village hall reconfiguring space within the toilets was due to commence later in the month.

Cllr Woods suggested the installation of an EV charging point at the village hall, Cllr Dempsey advised the village hall committee felt it was too early for one to be installed. Cllr Woods reported that works to the crossroads had been further delayed due to the surveying work.

Cllr Shepherd highlighted the outstanding clearance of the Moss View Road footway.
